Course Description

This course is designed to give students a perspective on the history of pharmacologic discoveries. Students will read historical articles and research the biography and impact of the study on human health and research progress. Students will learn presentation skills and participate in small group discussion.

Learning Objectives:

- 1. Describe the historical context of a variety of pharmacologic milestones and develop an appreciation for the impacts of the past on drug development.
- 2. Develop research skills by gathering information related to milestone medical pharmacology discoveries
- 3. Compile information to create and present an interactive presentation
- 4. Discuss milestones in medical pharmacology as both a presenter and a member of the audience
- 5. Evaluate presentations and provide meaningful feedback to peer presenters
- 6. Utilize feedback from the instructor and peers to improve presentation skills

Course Materials:

Choices of milestone papers in several categories will be posted on Blackboard. Students will review the topics and choose papers and dates to present at the first class meeting. If a student would like to present a different topic, the topic needs approval by the instructor.

Grading Criteria:

- Students are expected to present 3 research paper presentations (75% of grade) as a powerpoint during the semester.
- Attendance and participation in discussion will account for the remaining 25% of the grade. All papers will be supplied on Blackboard, so students who are not presenting are expected to review the basic premise of the paper, but not expected to be an expert. Students will provide peer reviews for all presentations
- Evaluations will be provided after each presentation (peer and instructor) and improvement will be considered in the final grade.

**Note, absences from class will require the student to write a topic review for the papers that were discussed. If a student cannot attend due to quarantine or mild illness, they could present/attend remotely using Zoom.

The presentations should be 20-30 minutes and include:

- 1. Outline/Objectives of the presentation
- 2. Biography of the principle investigator (timeline, personal info, awards, etc)
- 3. Overview of the paper
 - -state of the field at the time
 - -describe the methods and primary results (choose critical figures, do not cover every figure, this is not a journal club)
 - -must give the primary impact of the research
- 3. State of the field today---with a current model of the system studied or current pharmacologic uses/side effects. Papers dated prior to 1980 are presented with a new paper that uses the technology in a modern setting in the discussion.
- 4. Discussion questions---one or two questions for the audience, can be a multiple choice question or a case example to determine if the audience learned the main points.

Feel free to be creative with historical information/photos/etc. Projector and computer are available. Students can use a flashdrive or can access their email to download onto the classroom computer (preferred).
